Statement by the International Commission against the Death Penalty: USA Attorney General orders halt to federal executions

The International Commission against the Death Penalty (ICDP or Commission) warmly welcomes Attorney General Merrick Garland's order to halt federal executions in the USA on 1 July 2021. Reports suggest that the decision to declare a moratorium on federal executions was made in order for the Justice Department to conduct a review of its policies and procedures.

"ICDP believes that this is a good initial step and notes the justification of the moratorium by Attorney General Merrick Garland that, "(s)erious concerns have been raised about the continued use of the death penalty across the country, including arbitrariness in its application, disparate impact on people of color, and the troubling number of exonerations in capital and other serious cases." More steps need to be taken to ensure that there are no more executions at the federal level including commutations," said the Commission's President Judge Navi Pillay.

Reports reaching ICDP suggest that Attorney General Garland has cited President Joe Biden's strong opposition to capital punishment and also reiterated concerns on the use of capital punishment, which have arisen following several offenders being wrongfully convicted and sentenced to death. In such circumstances, there is always the risk of the execution being carried out of an innocent person. In this regard, ICDP notes that since 1973, in the USA, 185 inmates, under sentence of death, have been exonerated after being wrongfully convicted.

The 1 July 2021 moratorium on executions carried out at the federal level symbolizes a move away from the resumption of executions, after a hiatus of 17 years, on 14 July 2020. An unprecedented 13 people were executed during the final months of the last administration with the last execution being carried out a week before the inauguration of current President Joe Biden.

Background
